



## Membership Categories 2019 Season

CATEGORIES	DUES	DESCRIPTION
FAMILY	\$4,326	Full use of all club facilities by immediate family members
SINGLE	\$3,502	Full use of all club facilities by member only. Spouse and kids may use all facilities excluding VSICC golf course.
JUNIOR EXECUTIVE Family	\$3,275	Full use of all club facilities by immediate family members. ( Open to members ages 31-35)
JUNIOR EXECUTIVE	\$2,550	Full use of all club facilities by member only. Spouse and kids may use all facilities excluding VSICC golf course (Open to members ages 31-35).
JUNIOR (Step II)	\$2,150	Full use of all club facilities by member only (\$170 month) (Open to members ages 26-30).
JUNIOR (Step I)	\$1,600	Full use of all club facilities by member only (\$123.75 month.) (Open to members ages 18-25).
JUNIOR STUDENT	\$700	Restricted use of club facilities by members not exceeding the four year college level. Weekend and holiday play after 3pm. Restricted tournament play.
FAMILY POOL	\$600	Full use of club facilities by immediate family excluding golf course privileges
SINGLE POOL	\$500	Full use of club facilities by member excluding golf course privileges.

*"Family" as used herein shall mean domestic partners, spouses and unmarried children who are full-time students not exceeding the four-year college level or age 23 (at the opening of the season) and residing with their parent(s).*

*All dues and assessments are subject to NYS tax.*

*All members are responsible for the full year of dues. Dues may be paid in twelve monthly installments. Pool and Junior Student dues are payable in two installments.*

*A year-around monthly house minimum of \$40.00 is applicable to all membership levels.*

## 2019 Corporate Membership Program

### Who Is Eligible

Open to all businesses and private organizations.

Corporate members may chose from any of the following packages:

#### **Century Package**

\$5,500

125 Golf Passes (Includes carts)

50 Pool Passes

10 Hours of golf clinics for sessions with 4 or more golfers.

#### **Continental Package**

\$2,900

50 Golf Passes (Includes carts)

25 Pool Passes

5 Hours of golf clinics for sessions with 4 or more golfers.

#### **Spindle City Package**

\$1,800

25 Golf Passes (includes carts)

10 Pool Passes

2 Hours of golf clinics for sessions with 4 or more golfers.

#### Note:

1. Current members in single or family categories may not switch to corporate memberships.
2. Applicants must be a duly incorporated business or non-profit organization.
3. Full payment is due when application is approved.
4. Golf passes may be split into 9 hole passes.
5. Anyone using passes must comply with all VSICC rules.

## Discount Membership Program

### Half Price

Candidates who have not been members of the Van Schaick Island Country Club at any time for the last 3 years are eligible to join the club for the 2019 season for half the cost of a full golf membership. This offer is extended to family golf memberships as well but not to any other membership categories.

**Family Membership**  
**\$2,163** plus tax

Full use of all club facilities by immediate family members.

**Single Membership**  
**\$1,751** plus tax

Full use of all club facilities by member only. Spouse and kids may use all facilities excluding VSICC golf course.

1. This program was formerly called the "2 for 1" program.
2. Half Price members are liable for the full monthly clubhouse minimum (\$40)
3. All other optional fees such as cart fees, handicap fees etc. are at full price for each.
4. This offer is good for the 2019 season only.
5. Members who joined in the fall of 2018 after October 1 and who wish to take advantage of the 2019 *Half Price* program may do so and will have the amount of the October 1, 2018 joining fee credited to their account in 2019
